 - Damages incurred on any personal or private property due to driving through or removing of barricades.
 - Scars, marks etc. left on new asphalt when the surface is driven on before the proper amount of cure time.
 - Schedule delays due to weather conditions or other circumstances beyond its control.
 - Sub base/sub grade failure unless such work is included in our proposal.

Any alterations or deviations from above specifications will be done only with written orders, and will become an extra charge.

Warranty - There will be a one year warranty on the materials and workmanship except on the material applied to cracks, oil spots, and weeds growing through asphalt.

The warranty shall be limited to the replacement of the material and applications & excludes normal wear & tear.

Payments to be made as follows: 50% deposit required to begin work, 50% due directly upon completion.
